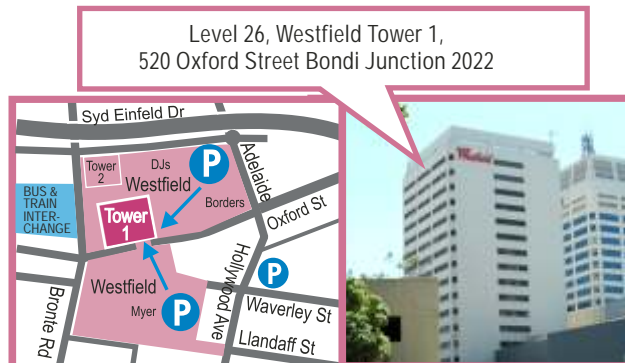

The Need:

Approximately 4% of all children born in Australia are the result of Artificial Reproductive Technologies(ART), including Donor Insemination (DI).

Donor sperm is required to achieve a pregnancy when no fertile sperm is otherwise available, for example when the male partner is infertile or there is no male partner.

The Result:

Providing donor sperm results in the most precious gift of all to the recipient women:- a child that otherwise would have been impossible.

FERTILITY EAST maintains a significant donor sperm bank with a good selection of sperm donors which meet current health and legal screening requirements, allowing the recipients to have a confident choice of donors.

- A general health check

- The screening test results will be made available to you in confidence.
- Reimbursement for any expenses you might incur providing the sperm donation.

Legal Aspects:

Current NSW legislation has been in force since January 2010. In addition to donors being identifiable (i.e.when the child reaches 18 years and if desired can be given contact details for the donor) a donor register is also being kept.

Under section 14 of the NSW Status of Children Act 1996, a semen donor is presumed not to be the legal father of any child born as a result of assisted reproduction using donor semen. This means that the donor will generally not be liable under the laws governing child support, inheritance and related issues. In most cases, the legal parents of the child will be the birth mother and her male partner, if she has one.

Sperm Donor Screening Q & A

Please consider carefully the following points:

● Location

Are you able to donate in Sydney:-
Fertility East, Westfield Tower 1, 520 Oxford St, Bondi Junction?

● Age

Are you between the age of 25 and 40?

● Health

Are you in good health? - you will be asked
- Do you smoke?
- Do you drink to excess?
- Do you partake in recreational or illegal drugs?

● Donor Education Session (Mandatory)

Both you and your partner (if applicable, male or female) must attend an education session with a qualified donor counsellor.

● Lifestyle declaration

You will have to fill in a comprehensive lifestyle declaration which includes questions relating to present and past sexual activity and preferences. (This does not exclude you if you are gay or bisexual).

● Consent to identifying information

You will have to consent to making available any identifying information to any resulting children (when at the age of 18) if they so desire.

● Payment

There is no payment for sperm.
Expenses within reason (travel, time etc) will be covered.

● Medical and physical check-up

If your initial semen analysis is OK we will conduct:-

- A medical and physical check-up
- Blood screens and infectious disease tests
- You (and partner) will be required to sign the appropriate consent and lifestyle forms.

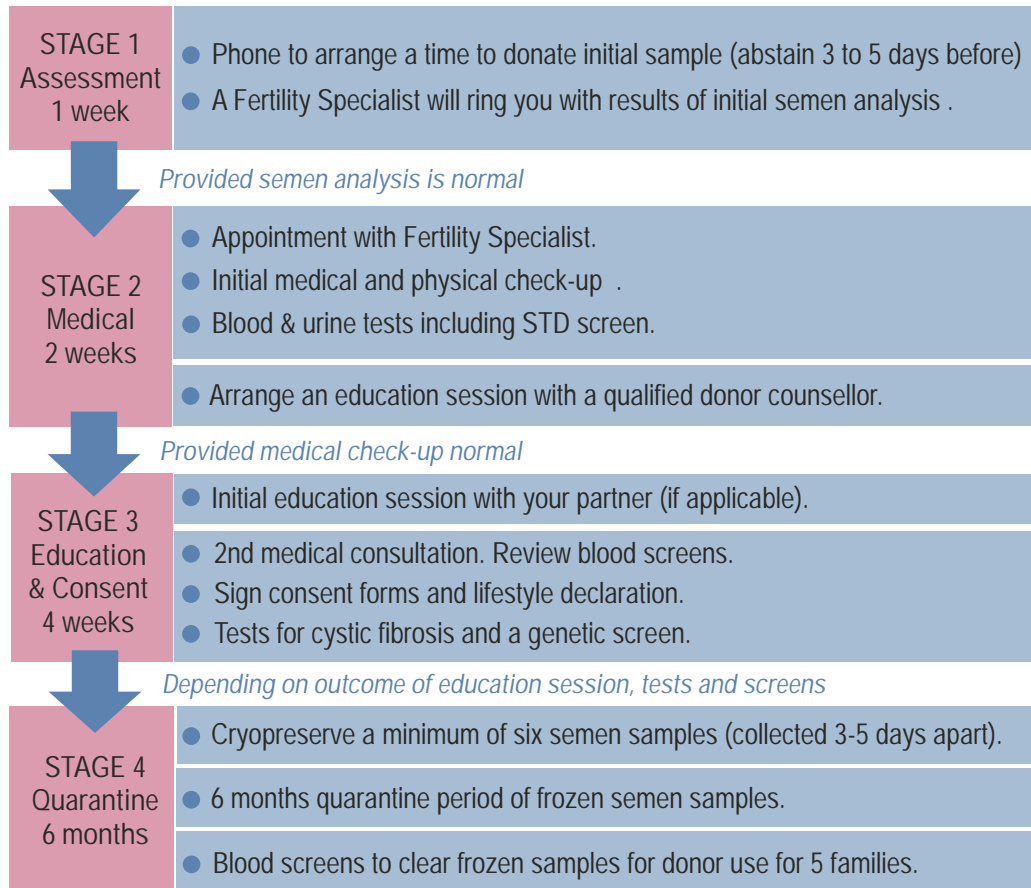
● Second blood screening 6 months later

You will be required to attend a second blood screening to clear original samples after 6 months quarantine period.

If you are in agreement up to this point, then the next step is to make an appointment with us 9389 1177 weekdays between 9.30am and 11am to conduct an initial semen analysis.

Depending on outcome we will arrange the appropriate consultation with a Fertility Specialist.
